## SHOW LOCATION, CRATING AND GROOMING

All events will be held in the facility main room. Crating will be available inside. Please stack crates to maximize crating room. No ex-pens or dryers allowed in the building.

Please help keep show grounds and building clean. Exhibitors will be responsible for their own messes.

#### **CONFORMATION**

We will offer four all breed conformation shows – two on Saturday and two on Sunday. All regular UKC conformation classes will be offered for regular and altered as well as Junior Showmanship. We are offering the following non-licensed classes: Novice Puppy, Veteran, and Brace. Total Dog/Total Junior will be offered Saturday and Sunday.

For each group, breeds will be judged alphabetically with regular dogs first, then altered, and finally non-licensed classes. Best of Breed winners for regular and altered classes will go to group while non-licensed classes go straight to Best in Show. Group competition will be held at the conclusion of breed judging for each group.

Best in Show and Reserve Best in Show will be awarded for regular, altered, and each non-licensed class at the end of the show.

Shows will start at 9:00 a.m. each day.

## **RALLY OBEDIENCE**

We will offer six rally trials – two each day. All levels of rally will be offered (Level 1,2,3 and Master). On Friday Rally will start at 12:00 p.m. and on Saturday and Sunday it will start at 8:00 a.m.

#### **OBEDIENCE**

We will offer six obedience trials – two each day. Pre-Novice to Utility will be offered. On Friday Obedience will start at 12:00 p.m. and on Saturday and Sunday it will start at 8:00 a.m.

## **NOSEWORK**

We will offer two nosework trials on Friday. Novice to Elite will be offered each day in interiors and containers. The trials will start at 8:00 a.m.

## **TOTAL DOG / TOTAL JUNIOR**

Total Dog / Total Junior will be offered Saturday and Sunday for dogs competing in conformation and obedience or rally / juniors competing in junior showmanship and obedience or rally. Special note: if you qualify in nosework on Friday, this will count towards Total Dog on Saturday only.

Total Dog Best in Show will be offered Saturday and Sunday for all the Total Dog recipients at the conclusion of the show. If you earn a Total Dog or Total Junior award, please check in at the front desk.

#### **Pre-Entries**

Pre-Entries must be received by February 6, 2024.

## **Day of Show Entries**

Day of Show Entries will be accepted online starting at the close of pre-entries with the exception of Obedience which is **PRE-ENTRY ONLY**. All day of show entries will be online. You may enter online at any time prior to the close of day of show entries – you do not need to be at the show site. **Day of Show entries at the show site will be as follows:** 

Nosework	7:00 - 7:30 a.m. Friday
Rally Obedience	7:00 - 8:00 a.m. each day
Obedience	PRE-ENTRY ONLY
Conformation	7:00 - 8:00 a.m. Saturday and Sunday

You may enter at the show site if you need assistance or wish to pay in cash/check.

If an event reaches the limit of entries, it may close sooner and not offer day of show entries.

## **General Entry Information**

#### All entries require payment to be considered a valid entry.

Dogs must be permanently registered with the UKC, have a Temporary Listing number (TL) or have a Performance Listing number by the closing date and time in order to enter. No exceptions will be made. Entries for ineligible dogs will be returned. Non-licensed puppies are not required to have a UKC number to compete.

Requests for cancelling entries prior to the closing date will be honored, subject to a \$15 administrative fee. No refund of entry fees will be made for entries cancelled after the pre-entry closing date. Entry fees will not be refunded if a dog is absent, disqualified, excused by veterinarian or judge, or barred from competition by action of the Event Committee. No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public, or any other cause beyond the control of the show committee.

In the event a female comes into season and cannot compete in a performance event, entry fees will be refunded minus a \$20 administrative fee provided that a veterinary note is provided. Written notice must be given not later than ½ hour prior to the start of any event.

Owners are responsible for the accuracy of information in the entry forms, regardless of who may make such errors. If an exhibitor is not called for their correct class or is called for an incorrect class, it is their responsibility to ask the steward to stop the show and check with the show secretary to correct the error. Owners and exhibitors are responsible for correcting any errors in their entry.

Pre-entries cannot be modified after the closing of pre-entries other than for move-ups and corrections. If a dog is entered in only some of the shows during a weekend (for example Saturday only) the entry cannot be modified to switch shows (for example switching to Sunday only) even if they are absent for some shows. An un-entered dog may not be substituted for an entered dog.

Returned checks do not constitute a valid entry fee. The club will add a \$35 fee for each returned check.

The show giving club, their agents, and employees, etc., assume no responsibility for any loss, damage, or injury, sustained by exhibitors, handlers, or any of their dogs or property.

## **Move-Up Information**

Dogs that, according to their owners' records, have completed the requirements for a championship or grand championship after the closing of entries, may be transferred to the champion or grand champion class if a request for transfer is made in writing to the show secretary no later than ½ hour prior to the start of any regular judging at the show. The only exception to this is when two conformation shows are running concurrently. If dog completes a championship in show 1, the request may be submitted any time before the start of judging of the breed in show 2.

Performance events will allow moveups from day to day only. The request must be made in writing to the show secretary not later than ½ hour prior to the start of any regular judging at that trial.

All other corrections to entries must be made in writing to the show secretary not later than ½ hour prior to the start of any regular judging at that show.

## **HOTELS/CAMPING**

Exhibitors must contact hotels directly and identify themselves as having dogs. Be sure to verify the dog policy and charges with the hotel of your choice when you make your reservation.

- Baymont by Wyndham Baldwin Up to 3 pets with a max weight of 20lbs are welcome with a non-refundable charge 20USD per pet per night.
- AmericInn by Wyndham Baldwin 2 pets max. 80lbs or less per pet. / Fees 25USD per pet per night.
- Super 8 by Wyndham Menomonie WI 2 pets max. Dogs only. / Fees 15USD per pet per night.
- We suggest searching for other area hotels in Baldwin or Menomonie for additional options. Baldwin is about 20 min away and Menomonie is about 25 min.

## LOSS/DAMAGE

The club, show chairperson, show secretary, and club members are not responsible for loss/damage to any dogs exhibited or for the possession of any participant, whether the result of accident or other cause. It is expressly understood that every dog at these shows is in the care, custody & control of the owner or handler. This also includes the hotels/motels.

#### **SAFETY**

If because of riots, civil disturbances, or other acts beyond the control of the club it is impossible to open or to complete a show or trial, no refund of entry fees will be made. If, in the opinion of the club, the well-being of dogs, exhibitors, or spectators is at risk due to extreme weather conditions, such as but not limited to snowstorms, hurricanes, lightening or extreme heat, the club may cancel or stop a show or trial before completion. No refunds will be made in such cases.
