CRATING & GROOMING

Crating area inside will be limited. No ex-pens allowed in the building. No dryers in the building. Please help keep show grounds & building clean. Exhibitors will be responsible for their own messes.

LOSS/DAMAGE

The club, show chairperson, show secretary, and club members are not responsible for loss/damage to any dogs exhibited or for the possession of any participant, whether the result of accident or other cause. It is expressly understood that every dog at these shows is in the care, custody and control of the owner or handler. This also includes the hotels/motels.

SAFETY

If because of riots, civil disturbances, or other acts beyond the control of the club it is impossible to open or to complete a show or trial, no refund of entry fees will be made. If, in the opinion of the club, the well-being of dogs, exhibitors, or spectators is at risk due to extreme weather conditions, such as but not limited to snowstorms, hurricanes, lightening or extreme heat, the club may cancel or stop a show or trial before completion. No refunds will be made in such cases.

CONFORMATION

We will offer six all breed conformation shows – two each day. All regular UKC conformation classes will be offered for regular and altered as well as Junior Showmanship. We are offering the following non-licensed classes: Novice Puppy, Veteran, Brace. Total Dog/Total Junior will be offered all three days.

For each group, breeds will be judged alphabetically with regular dogs first, then altered, and finally non-licensed classes. Best of Breed winners for regular and altered classes will go to group while non-licensed classes go straight to Best in Show. Group competition will be held at the conclusion of breed judging for each group.

Best in Show and Reserve Best in Show will be awarded for regular, altered, and each non-licensed class at the end of the show.

Each day show 1 will start at 9:00 am followed by show 2 at 9:15 am.

American Eskimos are not offered Friday show 2. Belgian Shepherds are not offered Saturday show 2. All other breeds are offered all shows.

Judging order for all conformation shows will be determined based on the pre-entries and our available workers. The final judging order will be posted near the ring on the day of show. If possible, it will be posted before the show in our Facebook group but is subject to change.

RALLY OBEDIENCE

We will offer six rally trials – two each day. Both trials will start at 8:30 am.

NOSEWORK

We will offer five nosework trials. On Friday we will offer one trial with all four elements (containers, interiors, exteriors, and vehicles. Saturday we will offer two trials with interiors and vehicles only. Sunday we will offer two trials with containers and exteriors only. All trials will start at 9:00 am each day.

TOTAL DOG / TOTAL JUNIOR

Total Dog / Total Junior will be offered each day for dogs competing in conformation / juniors competing in junior showmanship and one or more of the performance events.

Total Dog Best in Show will be offered each day for all the Total Dog recipients at the conclusion of the show. If you earn a Total Dog or Total Junior award please check in at the front desk.

ENTRY INFORMATION

Pre-Entries

Pre-Entries must be received by June 18, 2025.

Day of Show Entries

Day of Show Entries will be accepted online starting at the close of pre-entries.

Day of Show entries at the show site will be accepted as follows:

CONFORMATION - from 7:00 - 7:30 am each day.

RALLY - from 7:00 - 7:30 am each day.

NOSEWORK - from 7:30 - 8:00 am each day.

Day of show entries will be online. You may enter online at any time prior to the close of day of show entries – you do not need to be at the show site.

General Entry Information

All entries require payment to be considered a valid entry.

Dogs must be permanently registered with the UKC, have a Temporary Listing number (TL) or have a Performance Listing number by the closing date and time in order to enter. No exceptions will be made. Entries for ineligible dogs will be returned. Non-licensed puppies are not required to have a UKC number to compete.

No refund of entry fees will be made for pre-entries cancelled after the pre-entry closing date. Entry fees will not be refunded if a dog is absent, disqualified, excused by veterinarian or judge, or barred from competition by action of the Event Committee. No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public, or any other cause beyond the control of the show committee.

Owners are responsible for the accuracy of information in the entry forms, regardless of who may make such errors. If an exhibitor is not called for their correct class or is called for an incorrect class, it is their responsibility to ask the steward to stop the show and check with the show secretary to correct the error. Owners and exhibitors are responsible for correcting any errors in their entry.

Pre-entries cannot be modified after the closing of pre-entries other than for move-ups and corrections. If a dog is entered in only some of the shows during a weekend (for example Saturday only) the entry cannot be modified to switch shows (for example switching to Sunday only) even if they are absent for some shows. An un-entered dog may not be substituted for an entered dog.

Requests for cancelling entries prior to the closing date will be honored, subject to a \$15 administrative fee. No refund of entry fees will be made for entries cancelled after the pre-entry closing date. Entry fees will not be refunded if a dog is absent, disqualified, excused by veterinarian or judge, or barred from competition by action of the Event Committee. No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public, or any other cause beyond the control of the show committee.

Returned checks do not constitute a valid entry fee. The club will add a \$35 fee for each returned check.

The show giving club, their agents, and employees, etc., assume no responsibility for any loss, damage, or injury, sustained by exhibitors, handlers, or any of their dogs or property.

Move-Up Information

Dogs that, according to their owners' records, have completed the requirements for a championship or grand championship after the closing of entries, may be transferred to the champion or grand champion class if a request for transfer is made in writing to the show secretary no later than ½ hour prior to the start of any regular judging at the show. The only exception to this is when two conformation shows are running concurrently. If dog completes a championship in show 1, the request may be submitted any time before the start of judging of the breed in show 2.

NEW: Performance events will allow moveups between trials on the same day or day to day. For day to day moveups, the request must be made in writing to the show secretary not later than ½ hour prior to the start of any regular judging at that trial. For same day moveups, you must see the show secretary before running in the new class.

All other corrections to entries must be made in writing to the show secretary not later than ½ hour prior to the start of any regular judging at that show.
