CONFORMATION

We will offer four all breed conformation shows – two each day. All regular UKC conformation classes will be offered for regular and altered as well as Junior Showmanship. We are offering the following non-licensed classes: Novice Puppy, Veteran, Brace, Stud Dog, Brood Bitch. Total Dog/Total Junior will be offered both days.

For each group, breeds will be judged alphabetically with regular dogs first, then altered, and finally non-licensed classes. Best of Breed winners for regular and altered classes will go to group while non-licensed classes go straight to Best in Show. Group competition will be held at the conclusion of breed judging for each group.

Best in Show and Reserve Best in Show will be awarded for regular, altered, and each non-licensed class at the end of the show.

Both conformation shows will start at 9:00 a.m. each day.

JUDGING ORDER

Judging order for all events will be determined based on the pre-entries and our available workers. The final judging order will be posted near the ring on the day of show. If possible, it will be posted before the show in our Facebook group but is subject to change.

ENTRY INFORMATION

Pre-Entries must be received by May 3, 2024.

Pre-Entry fees: Licensed Classes: \$28, JS \$10, NLC \$10

Pre-Entry Special: \$100 All 4 Shows or Trials, Same Dog

Day of Show Entries will be accepted from 7:00 – 8:00 a.m. each day.

Day of Show fees: Licensed Classes \$30, JS \$10, NLC \$10

Pre-entries may also be mailed to: Tracie Karsjens, 13620 67th Ave N, Maple Grove, MN 55311. Checks may be made out to DODGE COUNTY CANINE CLUB or DCCC. **All entries require payment to be considered a valid entry.**

Dogs must be permanently registered with the UKC, have a Temporary Listing number (TL) or have a Performance Listing number by the closing date and time in order to enter. No exceptions will be made. Entries for ineligible dogs will be returned.

No refund of entry fees will be made for pre-entries cancelled after the pre-entry closing date. Entry fees will not be refunded if a dog is absent, disqualified, excused by veterinarian or judge, or barred from competition by action of the Event Committee.

Owners are responsible for the accuracy of information in the entry forms, regardless of who may make such errors. If an exhibitor is not called for their correct class or is called for an incorrect class, it is their responsibility to ask the steward to stop the show and check with the show secretary to correct the error. Owners and exhibitors are responsible for correcting any errors in their entry.

Dogs that, according to their owners' records, have completed the requirements for a championship or grand championship after the closing of entries, may be transferred to the champion or grand champion class if a request for transfer is made in writing to the show secretary no later than ½ hour prior to the start of any regular judging at the show. The only exception to this is when two shows are running concurrently. If dog completes a championship in show 1, the request may be submitted any time before the start of judging of the breed in show 2.

All other corrections to entries must be made in writing to the show secretary not later than ½ hour prior to the start of any regular judging at that show.

Pre-entries cannot be modified after the closing of pre-entries other than for move-ups and corrections. If a dog is entered in only some of the shows during a weekend (for example Saturday only) the entry cannot be modified to switch shows (for example switching to Sunday only) even if they are absent for some shows. An un-entered dog may not be substituted for an entered dog.
