2. Medical Attention/Disclosure: I understand and agree that engaging in canine activities or merely being at the Facility exposes me to inherent risks of personal injury that may require medical attention including, but not limited to, first aid and/or emergency medical care. I therefore consent to personal contact by Released Parties and/or medical personnel deemed necessary for providing for my care at the Facility and/or the hospital for my safety and the safety of others. I agree to hold Released Parties harmless for such medical attention and any Loss directly or indirectly resulting therefrom even at the risk of my COVID-19 exposure. I agree that in the event I am diagnosed as infected with COVID-19, I authorize medical personnel to provide Total Recall School for Dogs information regarding my Loss and treatment.

3. Release/Hold Harmless/Defend/Indemnify: I agree to release, hold harmless, defend, and indemnify Total Recall and their respective heirs, beneficiaries, agents, successors, assigns, instructors, trainers, employees, volunteers, independent contractors, working students, assistants, sponsors, guests, visitors, members, managers, officers, directors, owners, related entities, and others acting on their behalf (collectively “Released Parties”) from and against any liability, attorneys’ fees, costs, or other Loss I may incur arising out of or in any way connected with my exposure to or contraction of COVID-19 as a direct or indirect result of my presence at the Facility whether caused by my negligence or the negligence or other wrong doing of Released Parties (other than a willful and wanton or intentional misconduct).

4. Bound Parties/Governing Law/Jury/No Expiration/Time

Limitations/Severability/Modifications: I understand and agree the terms of this Agreement are binding on my spouse, partner, family members, minor child, heirs, agents, trustees, beneficiaries, representatives, relatives, successors, and assigns and I agree to all the terms and conditions of this Agreement on my own behalf and on behalf of my minor for purposes of permitting our presence at the Facility. In the event of a claim or dispute arising out of or relating to the interpretation or enforcement of this Agreement, I agree Minnesota law applies, that all disputes surviving this Agreement must be resolved exclusively by the state court in Washington County, and I waive my right to a jury trial. I agree that this Agreement does not expire and that any surviving claims must be brought within one (1) year of the date accrued. If any provision of this Agreement is deemed invalid or unenforceable, the remaining provisions shall be valid and enforceable to the fullest extent of the law. This Agreement can only be modified in writing signed by myself and Total Recall School for Dogs.

RELEASE, WAIVER, HOLD HARMLESS, ASSUMPTION OF RISK, DEFEND AND INDEMNIFY AGREEMENT FOR INFECTIOUS DISEASE INCLUDING COVID-19 RELATED LOSS

WARNING: IMPORTANT NOTICE

BY SIGNING THIS AGREEMENT, YOU ARE GIVING UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO RECOVER DAMAGES IN CASE OF ILLNESS, INJURY, OR DEATH (collectively "Loss") ARISING OUT OF YOUR PRESENCE AT THE FACILITY SPECIFICALLY RELATED TO COVID-19 OR ANY OF ITS MUTATIONS, FORMS, DERIVATIVES, OR OTHER INFECTIOUS DISEASE (collectively "COVID-19").

I, the undersigned, hereby enter into this Release, Waiver, Hold Harmless, Assumption of Risk, Defend, and Indemnify Agreement for Infectious Diseases Including COVID-19 Related Loss ("**Agreement**") in consideration of my, and my minor child if applicable (collectively "I", "me", or "my"), ability and permission to access, utilize, occupy, visit, attend, or otherwise be present on the Bloomington Obedience Training Club property ("the **Facility**") during and after the COVID-19 pandemic, for any reason, whether or not related to canine or canine activities

1. Risk of Loss/Protective Measures/No Guarantee: by signing this Agreement, I hereby acknowledge that I have familiarized myself with the risk of loss being present at the Facility for any reason whatsoever and the protective measures at the Facility intended to minimize my risk of exposure to COVID-19. I agree the protective measures are satisfactory and sufficient for me to accept and assume the risk of my COVID-19 exposure resulting from accessing, utilizing, occupying, visiting, attending, or otherwise being at the Facility occupied by other individuals; however, I understand and agree that Released Parties cannot guarantee: (a) the protective measures can or will prevent my exposure to COVID-19; (b) will be complied with by all individuals at the Facility; or (c) that others will not act in a negligent manner that may contribute to my Loss or contraction of COVID-19. I agree to fully comply with all protective measures required by the Facility as they now exist or may be revised from time-to-time. I accept full responsibility for my own safety and the sanitation of myself and my personal property and/or other personal property I contact at the Facility. If I am a parent or legal guardian of a minor individual at the Facility, I consent to the minor's presence at the Facility and agree to remain responsible for the minor's Loss and minor's compliance with all required protective measures.

ELIGIBILITY: Dogs must be permanently registered with UKC, have a Temporary Listing (TL) number (**Temporary listings available on line**), or have a Limited Privilege (LP) listing number in order to enter. No exceptions will be made. Entries for ineligible dogs will be returned.

PAYMENT: Payments may be made by cash, check, or money order; **payable in U.S. funds to “MMBC”**. No entry will be accepted without payment. Post-dated or returned checks do not constitute valid entry fees. MMBC will add a collection fee to the amount of each returned check. Exhibitors who repeatedly submit NSF entry fees may be put on a CASH ONLY basis.

CONFIRMATION: Written confirmation of entries will be made by email as soon as practical. If you do not receive your confirmation by the Friday preceding these events (Oct. 4, 2024), please notify:

GENERAL INFORMATION: Building will be open to exhibitors at 8 AM Saturday and Sunday. Overnight security is not provided, and no dog(s) may be left in the building overnight. Exhibitors may *at their own risk* leave crates and belongings overnight. Crating space is available indoors with matting protection.

CRATES AND CHAIRS: Due to the matting at BOTC, **ALL** crates and chairs need to have protective material placed under them to avoid damaging the matting.

There will be no pre-trial ring time available Friday night for this trial.

REFUNDS: No refund of entry fees will be made for entries cancelled after the closing date, except in the cases of bitches that come into season or injured dogs. In those cases, refunds may be obtained by providing a veterinarian's certificate to the Event Secretary before the start of the trials. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by a Judge, or barred from competition by action of the Event Committee or UKC.

If, because of riots, civil disturbances, or other acts beyond the control of the host organization and it is impossible to open or to complete a show or trial, no refund of entry fees will be made. If, in the opinion of the host club, the well-being of dogs, exhibitors or spectators are at risk due to extreme weather conditions, such as, but not limited to snowstorms, hurricanes, lightning, or extreme heat, the host club may cancel or stop a show or trial before completion. No refunds will be made in such cases.

NOTICE TO EXHIBITORS: Dogs may arrive any time prior to their scheduled time of judging. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In that case, no refund of any fees paid will be made. Exhibitors and dog owners are expected and required to clean up after their own dogs. Any person witnessing a violation of this rule must report it to the Event Committee. The Event Committee may ask any person violating this rule to leave the event grounds. No refund will be made if an exhibitor is asked to leave the grounds. Dogs may not be left unattended when crated in soft mesh crates. No dog may be left in an unlatched or unzipped crate. Dogs must be kept on leash except when being judged or when crated.

NOTE: If back-up judges are needed for these Obedience trials, pursuant to Section 14 of the Official Rules for Dog Events, a back-up-judge will judge prior to the starting time listed for each day to avoid interrupting concurrent runs. Pursuant to the Rules, judges will **NOT be eligible for placements or awards**. However, judges may earn All-Star and Championship points.
